AMENDMENT NO. 1 TO CONTRACT NO. Vendor-Marketing/Outreach-SCAD0423

THIS IS AMENDMENT NO. 1 TO **CONTRACT NO. Vendor-Marketing/Outreach-SCAD0423** by and between **CAREERSOURCE NORTH CENTRAL FLORIDA** hereinafter "CSNCF", the administrative entity and fiscal agent for the Dual County Council of Alachua and Bradford Counties and the North Central Florida Workforce Development Board, Inc. hereinafter "NCFWDB" having its principal office at 1112 North Main Street, Gainesville, FL 3260 and SCAD Media, LLC, hereinafter referred to as "Vendor", existing under and by virtue of the laws of the State of Florida as a for-profit Limited Liability Corporation having its principal office at 747 SW 2nd Ave IMB 32 #381 Gainesville, FL 32601 to begin on the date this Agreement is signed by all the parties and to terminate on September 30, 2024.

**RECITALS**

WHEREAS, CSNCF has entered into an agreement with the Governor of the State of Florida for the implementation of workforce development programs and activities in accordance with the Workforce Innovation and Opportunity Act of 2014, PL. 113-128 (WIOA); AND

WHEREAS, in accordance with WIOA, the CSNCF governing boards selected Sub-grantee to provide outreach and marketing services; and

WHEREAS the CSNCF governing boards have voted to extend the Contract for an additional 12-month period from July 1, 2023 through June 30, 2024;

NOW THEREFORE, in consideration of the premises and the mutual covenants and obligations herein contained, and subject to the terms and conditions hereinafter stated, the parties hereto agree as follows:

1. Paragraph II **Rates and Compensation**, Section A is amended to delete the stricken language and to substitute the underscored language for Section A as follows:
  - A. Contractor shall be paid up to ~~Fifty Two Thousand Five Hundred Dollars (\$52,500.00)~~ Fifty two thousand Dollars (\$52,000) for the Marketing/Outreach Services to be conducted under this Contract as follows:
    1. Payment shall be based on the CSNCF approved budget for each individual project requested as described in Article I during the contract period and in accordance with the new schedule attached as Exhibit A to this Amendment.
    2. CSNCF has approved activities outlined in Exhibit A for up to ~~50 hours~~ 50 hours per month. Contractor will submit a monthly activity log to document the project(s) worked on and the hours dedicated to those projects. Overages shall be at contractor's expense, unless preapproved by the CSNCF Executive Director in writing. During any month in which Contractor works less than ~~50~~ 50 hours they shall

be paid for actual hours worked per their fee schedule. In months where Contractor works less than ~~50-50~~ hours the hours may roll over to the next month during which Contractor can apply the hours as needed for outstanding projects up to the number of roll over hours. All invoices must detail the projects worked on and the actual hours dedicated to the project.

2. Paragraph 4 Contract Term is amended to substitute underscored language and to delete the stricken language as follows:

The term of this Contract shall begin on the date of execution through ~~June 30, 2023~~ June 30, 2024, or such other date as the parties may mutually agree upon, and may be renewed for two additional ~~three successive~~ one-year periods at the discretion of CSNCF and its governing boards and the availability of funds. The budget for the renewal periods shall be negotiated annually.

3. The following underscored language is added to create a new Section R in Paragraph X

Subgrantee shall adhere to 2 CFR 200.323 Procurement of recovered material.

4. The following underscored language is added to create a new Section S in Paragraph X

Subgrantee shall adhere to 2 CFR 200.322 Domestic Preferences for Procurement.

5. The following underscored language is added to create a new Section T in Paragraph X

Subgrantee shall adhere to 2 CFR 200.300 Statutory and National Policy Requirements

6. All provisions of said Agreement, which are not in conflict with this Amendment, shall continue to be enforced in accordance with the terms and conditions therein.
7. This Amendment and all its attachments are made a part of said Agreement.
8. The effective date of this Amendment shall be the date on which it has been signed by both parties.
