1. Budget True-Up

The seat was formerly held by Mr. Landon Harrar, of the Greater Gainesville Chamber of Commerce, who separated from the Chamber in December, making him ineligible to remain in the seat; and 2) with the permission of our Alachua County Commissioner Prizzia, who is assigned the appointment of the economic development representative, rotating the seat every 2 years to allow for the Economic Development Representatives of each of our 6 member counties to have the opportunity to serve on the Board. There is no requirement that the Representative be from Alachua County.

3. The Addition of CareerSource Northeast Florida to our Regional Planning Area (RPA)

Consideration of adding CareerSource Northeast Florida to our RPA. The Florida Workforce System Transformation Plan directed CareerSource Florida to establish RPA's. Our RPA, currently includes CareerSource Citrus Levy Marion and CareerSource North Florida. Our Regional Plan was approved by the CareerSource Florida Board in February 2025. The State has since requested that we add, CareerSource Northeast Florida which covers Baker, Clay, Duval, Nassau, Putnam and St. Johns Counties. We are recommending approval.

To date we are fully operational in Gainesville and the City of Alachua for Alachua County, Starke for Bradford County and Trenton for Gilchrist County with staff situated and providing services from those locations. We expect to be operational in Cross City for Dixie County by March 16, 2026, Lake Butler for Union County by March 23, 2026, and Lake City for Columbia County by April 1, 2026, which will complete our goal of having in person services provided in each of the six counties we serve.

Our staff is being hosted by Florida Gateway College and the Columbia County Economic Development Department in Lake City respectively and are currently serving clients from those locations.
