

**SECOND MODIFICATION TO
MEMORANDUM OF UNDERSTANDING**

THIS SECOND MODIFICATION TO MEMORANDUM OF UNDERSTANDING, made and entered into on the date of the last party to sign, is between CAREERSOURCE NORTH CENTRAL FLORIDA (“CSNCF”), as the administrative entity for and representing the Dual County Consortium Workforce Development Council (“DCCWDC”) and the North Central Florida Workforce Development Board (“NCFWDB”), and THE DISTRICT BOARD OF TRUSTEES OF SANTA FE COLLEGE, FLORIDA (“SF”), a body corporate of the State of Florida, and one-stop partner under the Workforce Innovation and Opportunity Act of 2014, P.L. 113-128 (“WIOA”).

WITNESSETH:

WHEREAS, CSNCF and SF are parties to a Memorandum of Understanding dated April 21, 2021, regarding the coordination of efforts to establish and maintain a one-stop system (MOU); and

WHEREAS, on May 31, 2024, a First Modification extending the term of such MOU until June 30, 2025, was agreed to by CSNCF and SF; and

WHEREAS, CSNCF and SF continue to partner regarding workforce training, advancing employment, and greater economic development and seek to further extend the term of the MOU; and

WHEREAS, this extension will help ensure uninterrupted service delivery and continued collaboration under the Workforce Innovation and Opportunity Act (WIOA).

NOW, THEREFORE, in consideration of the mutual terms, conditions, promises, covenants and obligations hereinafter set forth, CSNCF and SF agree as follows:

SECTION 6 of the MOU, entitled **Term**, is amended in its entirety to read:

This MOU shall commence on July 1st, 2021 and shall remain in full force and effect until **June 30, 2026**, unless the MOU is terminated by either Party in accordance with the terms set forth below and in Section 8 of the MOU.

SECTION 9B of the MOU, regarding notice to SF is modified to state:

B. All notices required to be given to SF under this MOU shall be sufficient when hand delivered or mail to Santa Fe College, Attn: Provost, 3000 NW 83rd Street, Gainesville, FL 32606 and courtesy copy via email to general.counsel@sfccollege.edu.

SECTION 15B of the MOU, regarding Public Records is modified to state:

B. IF CSNCF HAS QUESTIONS REGARDING THE APPLICATION OF CHAPTER 119, FLORIDA STATUTES, TO CSNCF'S DUTY TO PROVIDE PUBLIC RECORDS RELATING TO THIS CONTRACT, CONTACT THE PUBLIC RECORDS CUSTODIAN AT general.counsel@sfcollge.edu OR 3000 NW 83rd ST., GAINESVILLE, FL 32606.

SAVE and EXCEPT as expressly amended herein, all other terms and provisions of the original MOU between the parties shall be and remain in full force and effect.


