VI. Reports

1. At the June 3, 2026 CareerSource Florida Board of Directors meeting, Workforce Policy G103 – Performance Requirements for Local Workforce Development Boards (Revised) was approved. This state level Administrative policy makes changes to how boards are held accountable for performance. Staff will provide a more in depth report on the changes and what that means for the region and the workforce system as a whole.

1. Consideration to approve an updated OJT Policy which now is separated from the previous CSNCF OPS15 Work Based Training Policy

The State has issued a new OJT Policy which has been further modified by a recent waiver granted by USDOL which would allow for a 100% OJT wage reimbursement for employers. The State is requiring all local areas modify their policies to be aligned with the State's policy as well as use the State OJT Contract Template. The attached Policy incorporates the State's requirements to 1) use the state's contract template, 2) perform in-person monitoring, and 3) adopt the state waiver. There are some other changes but none are material.
